Business

Simple Business Checking: \$10/statement cycle if average minimum balance falls below \$100/statement cycle; \$.20/item over 500/statement cycle.

Business with Interest: \$10/statement cycle if average minimum balance falls below \$10,000/statement cycle; \$20/item over 500/statement cycle.

Business Money Market: \$10/statement cycle if balance falls below \$5,000/statement cycle.

Business Investor Savings: \$2/statement cycle if balance falls below \$100 minimum/statement cycle.

Business Certificate of Deposit (CD): Early withdrawal penalty may apply.

Personal

Green Checking: \$1/check after 3/statement cycle.

Interest Checking: \$10/statement cycle if balance falls below \$1,000 minimum/statement cycle.

Personal Investor Savings: \$2/statement cycle if balance falls below \$100/minimum/statement cycle.

Personal Money Market: \$10/statement cycle if balance falls below \$1,000 minimum/statement cycle.

Health Savings Accounts (HSA): One time set up fee of \$25; transfer out fee of \$50.

Personal Certificate of Deposit (CD): Early withdrawal penalty may apply.

Individual Retirement Accounts (IRA): One time set up fee of \$25; transfer out fee of \$50. Early withdrawal penalty may apply.
